Thomson Reuters Foundation Announces Global "2017 Stop Slavery Award" and Recognizes MGM for Its Leadership and Innovative Approach to Addressing Modern Slavery

[November 16, 2017, Macau] MGM is proud to be selected as a top 15 global finalist for the esteemed "Stop Slavery Award" presented by Thomson Reuters Foundation, the philanthropic arm of the world's biggest news and information provider. The selection identifies MGM for its best practices and continued leadership in combating human trafficking across the globe. The announcement was made on November 15 in London.

MGM is the first private sector organization based in Macau to bring the issue of human trafficking to the forefront. Our Company is focused on supporting the elimination of forced labor and its destructive effect on humanity. MGM has brought stakeholders from across the private, public and NGO sectors together to discuss opportunities for improvement in Macau and to foster collaboration in order to achieve meaningful progress.
