The proxy need not be a member of the Company but must attend the annual general meeting in person to represent you. Any alteration made to this proxy form must be initialed by the person who signs it.

If you do not indicate how you wish your proxy to vote, your proxy will be entitled to exercise his/her discretion or to abstain. Your proxy will also be entitled to vote at his/her discretion or to abstain on any resolution properly put to the annual general meeting other than those referred to in the notice convening the annual general meeting.
- 5. This form must be signed by you or your attorney duly authorised in writing or, in the case of a corporation, must be either executed under its common seal or under the hand of an officer, attorney or other person authorized to sign the same.
- 6. In the case of joint holders of any share, any one of such joint holders may vote at the annual general meeting, either personally or by proxy, in respect of such shares as if he were solely entitled thereto. However, if more than one of such joint holders be present at the annual general meeting personally or by proxy, the vote of the joint holder whose name stands first in the register of members of the Company and who tenders a vote, whether in person or by proxy, will be accepted to the exclusion of the votes of the other joint holder(s).
- 7. To be valid, this completed and signed proxy form and the relevant notarized power of attorney (if any) and other relevant document of authorization (if any), must be lodged with the Company's Hong Kong Listed Share Registrar, Computershare Hong Kong Investor Services Limited at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong not later than 10:00 a.m., Tuesday, May 23, 2023 (Hong Kong time) or 48 hours before the adjournment of the AGM (as the case may be).
- 8. Completion and return of the proxy form will not preclude you from attending and voting at the annual general meeting if you so wish. In such event, the instrument appointing a proxy shall be deemed to be revoked.

PERSONAL INFORMATION COLLECTION STATEMENT

Your supply of Personal Data to MGM China Holdings Limited is on a voluntary basis.
